ENERGY STAR® Appliance Agreement

July 1, 2024 – June 30, 2025

It is the joint interest of North Western Electric Cooperative (NVEC) and its members to reduce the electricity demand and promote the use of high-efficiency appliances. NVEC will offer a rebate to encourage energy efficiency for approved ENERGY STAR refrigerators, stand-alone freezers and central air units. To qualify for an appliance rebate, the member must agree to adhere to the following program requirements.

Appliance Specifications

- **Refrigerators and stand-alone freezers**
 - Size: 10-30 cubic feet
 - **Must be new and ENERGY STAR rated at the time of purchase and installation.**
See www.energystar.gov for current ENERGY STAR specifications.
 - Must verify the ENERGY STAR listing through either a copy of the yellow Energy Guide label or the owner's manual showing the ENERGY STAR logo.

- **Central air conditioning unit**
 - Must be a central air system.
 - The unit must have a minimum 16 SEER rating.
 - A max cap of 6 tons (no large commercial units).
 - Must include properly-sized ductwork, and installation shall comply with all applicable local and state electrical code requirements.
 - **Must be new and ENERGY STAR rated at the time of purchase and installation.**
See www.energystar.gov for current ENERGY STAR specifications.
 - Must verify ENERGY STAR listing through either a copy of the yellow Energy Guide label or the owner's manual showing the ENERGY STAR logo.
 - **Window and portable air conditioning units do not qualify.**

Conditions of Rebate

- Refrigerators and stand-alone freezers not meeting cubic feet requirements are not eligible for this program.
- Central air conditioning units not meeting 16 SEER minimum are not eligible for

this program.

- The Cooperative must verify through a purchase receipt that a new ENERGY STAR refrigerator, stand-alone freezer, or central air unit was purchased and installed between July 1, 2024, and June 30, 2025.

Rebate Requirements

- The building must be a residence that uses electricity from NWECC, no commercial or industrial buildings.
- Rebate is to be issued to the Cooperative member; the rebate cannot be paid to a builder/dealer.
- A rebate request form, proof of purchase, and proof of ENERGY STAR rating must be submitted to NWECC within 60 days of the purchase of the appliance.
- NWECC will issue a rebate in the form of a bill credit for approved refrigerators, stand-alone freezers and central air units.
- The bill credit will be applied to the member's electric service account where the appliance is installed.
- Rebate amounts:
 - Refrigerator and stand-alone freezers = \$100
 - Central air units = \$150
- A maximum of two ENERGY STAR refrigerators, ENERGY STAR two stand-alone freezers and two ENERGY STAR central air conditioner rebates, a maximum of six ENERGY STAR appliance rebates total, may be paid per member home in a program year.
- The rebate request forms are available in the NWECC office or can be printed from NWECC's website at www.nwec.com.

The Cooperative will periodically review this program to determine its continuance and value to our members.

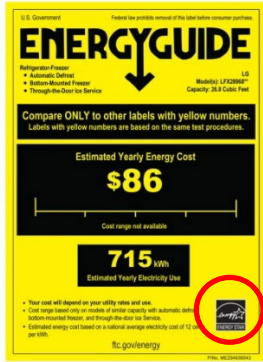
